2. Undertaking must be signed by the candidate.
3. Incomplete or unsigned and without self attested application will be rejected and no communication will be entertained in this regard.
4. Seats are reserved for EWS, SC, ST, and OBC & PWD (Ortho) as per Central Govt. Rules issued from time to time.
