Annexure 'A'Qualifications and term and conditions**Essential Educational qualifications:**

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate degree in the concerned Speciality or Super-speciality mentioned in Section-A of Schedule VI.
- (iii) At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar in the concerned Speciality or Super-speciality in a recognized teaching institution after obtaining the first Post-graduate degree.
- (iv) The candidate must possess the requisite qualification as on the date of interview.

NOTE:

1. In the case of holders of Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) qualification of five years' duration, the period of senior Post Graduate residency rendered in the last part of the said of Doctorate of Medicine(D.M.) or Magister Chirurgiae (M.Ch.) shall be counted towards requirement of teaching experience.
2. For recruitment to the post of Assistant Professor in the speciality of Clinical Haematology 'Doctorate of Medicine(Clinical Haematology); or Diplomat National Board(Clinical Haematology); or Doctor of Medicine(Medicine) or Doctor of Medicine(Paediátrics) or Doctor of Medicine (Pathology) or Diplomat National Board (Medicine/Paediatrics/Pathology) with at least two years' special training in Clinical Haematology and remaining one year in the Department of Medicine/Paediatrics/Pathology.
3. Teaching experience in any other post like the post of General Duty Medical Officer or Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

Candidates should report in the Room No. 16, Ground Floor of VMMC Building & SJH, New Delhi at 09.30 A.M. positively on the date of interview along with original and photocopies of relevant documents duly attested and application along with Bio-Data in prescribed Format super scribing the name of the post applied for, and two passport size photographs.

The competent Authority reserves the right for any amendment, cancellation and change in this advertisement in whole or part thereof without assigning any reason.

The terms and conditions for appointment of contract basis:-

1. Remuneration: Ist year Rs. 85,000/- p.m.(consolidated), IInd year Rs.95,000/- p.m.(consolidated). The contractual appointee will not be entitled to any allowances, financial benefits or concessions as admissible to Govt. employees. Income Tax will be deducted at source on monthly basis.
2. **Age of Candidates should not be more than 40 years of age on the date of interview. Relaxation as per rules of Central Govt.**
3. The contractual employment will be for a period of one year only or till regular incumbents join the hospital whichever is earlier. The services of the appointee are also terminable before expiry of the contractual period by either side after giving 30 days notice or salary in lieu thereof. The selection is purely contractual in nature and does not confer any right for regularization or permanent absorption.
4. Leave: The leave entitlement of the appointee shall be governed as per DOPT O.M. No.12016/3/84-Estt.(L) dated 12th April, 1985 and O.M.No.12016/1/96- Estt.(L) dated 5th July, 1990.
5. No TA/DA is admissible for the interview. Canvassing of any kind will lead to disqualification.
6. The appointee shall perform the duties assigned to him. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
7. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government servants appointed on regular basis.
